A food audit is usually a stressful event for the management of a food company and the outcome may determine the future success of the business and of an individual's career.

Some questions

- How frequently should a food business be audited?
- Is frequent auditing helpful for food safety and quality or does it actually create greater risk?
- Are HACCP and the all-important CCPs being buried under a weight of bureaucracy?
- What are the legal requirements?
- What schemes exist and how many are accredited?
- Who does the accrediting and how effective is it?
- Who audits the auditors?

These and many other questions will be addressed by this one day conference which is a timely response to a growing impression in some parts of the industry that it is suffering from audit fatigue and that maybe 'enough is enough'.

Who Should Attend?

Food Retail Directors and Managers, Food Auditing Professionals, Local Authority Environmental Health Officers, Food Company Directors, Food Factory Managers, Quality Assurance Specialists, Hygiene Officers, Food Consultants.

The conference will give attendees a better understanding of the food auditing landscape in the UK, the various organisations involved in auditing and accreditation, the legal requirements and the qualifications, credibility and competence of the auditors themselves. It is a unique opportunity for the various stakeholders to discuss the many issues associated with the food auditing process and will open up an important dialogue between those on the giving and the receiving ends of the auditing process.
